Polio Plus Update: The Board of Directors has established a goal for the Rotary Club of Redwood City of \$100,000 to be accumulated over the next five years. This means we need to find an additional \$20,000 per year. We have many proposals of how this will be done and these proposals are under study by the Polio Plus Committee. Needless to say we are going to need to raise this money from the Community and not soley from Rotarians. 

The Citation, signed by the R.I. President and District Governor, will be given to our Rotary Club when we meet five of the criteria out of the eight printed below.

1. Achieve a Three Percent Net Gain of members in your club. (In order to offset normal attrition of 10 percent, a 13 percent gross gain is needed. Membership gains will be computed on the basis of increases from 30 June, 1987, to 30 June, 1988.)

2. Sponsor a New Rotary Club.

3. Sponsor a New Interact Club, Rotaract Club or Rotary Village Corps.

4. Initiate at least one New Service Project in vocational service, community service, or international service, during your year.

5. Participation by Club President and Secretary in the District Assembly.

6. Increase Club Representation at the District Conference by Ten Percent over last year's representation.

Increase Contributions to The Rotary Foundation by Ten Percent over last year's contributions.

8. Meet the PolioPlus Goal.

The district governor will judge and certify the clubs in his district that qualify for the award, and should notify the secretariat by providing the names of the qualifying clubs and club presidents, no later than 30 July, 1988.





LAST WEEK: Pres. BILL called on ALLEN GRUMAN to lead the chorus and true to his promises, ALLEN gave another mini lecture on little historical side lights regarding the creation of our constitution whose 200th anniversary we will all soon be celebrating.

Chief GUARDINO leda d' pledge and CHARLIE BULANTI gave the invocation.

Recognizing our lady Rotarians, Pres. BILL presented BETH BERLIN with her regular badge and welcomed home JUDY SMITH, just returned from her annual tour with the Vanguards drill team, putting her a step ahead of Septembers' Youth Activities month.

August Program Chairman LEIF SYRSTAD (and it's pronounced "LAYF" not "LEEF") introduced our speaker, Margie Bush, Administrator of the Redwood City Neighborhood Boards Program.

Funded by the City of Redwood City, San Mateo County and private corporations and foundations, the Neighborhood Boards Program provides a free mediation service to seek resolution of neighbor to neighbor disputes and other conflicts of a more general nature (eg., landlord/tenant disputes).

Ms. Bush described and gave examples of the kinds of problems they deal with, noting that their mediated hearings have produced successful agreements 80% of the time. An interesting approach for neighbors who don't see eye-to-eye and often don't even know whose eye they're seeing.

NEWS AND NOTES: Past Pres. PETE is passing around a sign-up sheet soliciting voluntary assists in entertaining our exchange student arriving towards the end of this month. This is apart from the housing and involves things like tours by land, air or water, dinners, parties, visits to places, participation in family events, etc. Think of the many things you might be able to offer, big or little and let PETE know.

ROY FRANK reminds the special Events Committee that it's time to get started on planning for things like the Christmas Party. Get ready, get set, go, go.....go!

Pres. BILL notes that Dr. Joe Serra will be presenting his inspiring talk a slide show on the wonderful R.I. polio program in Mulawi at the Menlo Park Club on September 23. If you haven't seen it, don't miss this chance. Then on November 4, Menlo will be having Rick King - another program you shouldn't miss if you've never seen.

N.B.: Take a look at the August copy of The Rotarian. On page 23 there's a column entitled "a vital force today". It starts "Rotary is well known in Brazil. Anyone you meet - on the street, on a domestic airliner, in a business office or public institution, knows what Rotary is and what it does".

Read the article and then remind yourself of all the immense skills and talents the members of our club - and most any Rotary Club - possess. Now let your mind wander and think of all the areas of our community's life where you and your special knowledge can be of such value and make such a difference when that knowledge is offered for free to those in need who can't afford. We can make such a difference - doing what may seem to be little things (but big to those who don't know how) - in the name and spirit of Rotary and Service Above Self. Think about it.

REDISTRICT REPORT: The select committee to study splitting our District has meand returned a unanimous recommendation to the D.G. "Split the District into the Districts at the Marin Sonoma border." This was a much debated issue and the committee heard arguements that ran from split at Sonoma Mendocino to split at the Golden Gate. They felt the fairest and best split is per this proposal. We will need a vote on this issue soon. It is unreasonable to ask any one man to visit 64 or more clubs. The split would leave us in the south with 30 clubs and the north with 34. The potential to up over 40 clubs soon is very high.

They are brought together and organized by a sponsoring Rotary Club to develop projects for this purpose. An RVC agrees to undertake at least two projects annually, one to serve the community and the other to encourage respect for all useful work. Though it receives guidance from its sponsoring club, it is responsible for planning, financing, and executing all of its own activities.



Now returned from a year in New Zealand with his family, Paul spoke enthusiastically of his year "down under" engaged in a very successful research project at one of this island nations' five universities. Called "one in seven", the ratio of handicapped to normal H.S. students, the project received official sanctioning and additional nding from the government's department of education and, in Pauls' view, will have

a significant impact on teaching in this area not only in N.Z. but world wide.

Paul also gave an interesting description of the current economic, social and political conditions in New Zealand.

A fine program and real testimonial to the great and meaningful R.I. scholarship programs.

NEWS & NOTES: Cowboy BILL says we'll be hearing more of a new round-up program in the works dealing with that ever vital and critical matter of new members.

Past Pres. ROY says the Special Events Committee is trying to decide between a mid-week fishing trip on the "Wackey Jackey" for about 25-30 persons and an evening dinner and to the theatre party. In a show of hands it looks like both events have a good cadre of supporters. Maybe both can fly.

On September 24 there will be a ZONE Conference at the Marriot. Some tickets are still available for the luncheon at \$20.00 each. An exciting event with the first Rotary exchange student from China speaking at the luncheon and a full discussion taking place on the question of putting Rotary in China.

AVENUES OF SERVICE: In 1922 the RI convention refined the "objects" of Rotary. The early versions had emphasized the "business motives" but the gradual evolvement of goals reflected concerns common to a new organization; e.g., in 1910 the first object was "to extend and develop Rotary principles by the organization of affiliating Rotary clubs throughout America." In 1912 five objects covering such things as promoting the worthiness of all legitimate occupations, encouragement of high ethical standards, increasing efficiency by exchanging ideas, promoting acquaintance, and quickening the interest of each member in the public welfare and civic development were adopted.

In 1915 a sixth object was added to the club objects, "to stimulate the desire of each member to be of service to his fellow men and society in general." There were six objects until 1935 when the Mexico City Convention adopted four objects. In 1951 the convention agreed that Rotary had only one object with four parts. These parts, then, became the "four avenues of service": club, vocational, community, and international respectively.





So short a time ago, it seems, R.I. finally reached one million members. Where are we now? 1,040,440 in 23,145 clubs in 161 countries and geographical regions. WOW!

Keep reminding yourself to think of family outings or doings that might include our personable young exchange student from our sister club in La Paz who's presently staying

with Past Pres. PETE. You'll enjoy him and be a big help to PETE and those who foll in providing our visitor a home away from home.

POLIO PLUS: District 513 Polio Plus Chairman PDG Norm Lawrence conducted a training session for the area coordinators and others interested in Polio Plus fund raising at Santa Rosa this last Saturday. We are finally getting the horses in front of the cart, however, there are still many things to be done in order to properly mount our campaign. The one bit of information to come out of the Saturday session is the need for a personal financial commitment to the project by each Rotarian.

We have heard a great deal about Polio Plus but explanations of its origin and goals have been lacking.

Polio Plus was concieved as a project by our elected representatives to Rotary International and was approved by the RI Board and the Trustees of the Foundation. Originally it was to raise \$120 million and erodicate Polio from the world by the year 2005. This would require \$6 million per year of Foundation money and was considered "no big deal". When the project was presented to the World Health Organization, however, they suggested we do the project in five years and use the Rotary infrastructure to help them eradicate 5 other diseases; Diptheria, Pertussus, Tetanus, Tuberculosis and measles at the same time. Rotary agreed and proceeded to move the time table up to five years.

In order to help achieve the \$120 million goal RI hired Community Counseling Servio (CCS), a professional fund raising consultant. They advised that RI should raise to money, or at least receive the commitment, within two years, by June 1989.

The project has taken on a life of its own and has grown over the period of time since its inception. This accounts for the many changes and false starts which we have seen. Now with the CCS involvement the plans have been solidified. They propose a campaign within Rotary and have outlined the plan at Saturdays meeting. They then suggest community involvement outside Rotary which we have discussed at our General Meetings. The Rotary Club of RWC is on track and will soon begin our solicitation campaign with a community event hopefully to be planned for the late spring.

Our committee will soon be trained by our area coordinator DR. CHUCK EID. Once trained we will let you know how we will go forward with our Polio Plus commitment.

In the same period undesignated gifts (three that apply to the Foundation's basic programs such as scholarships, exchanges, etc.) have declined 59%.

TIME TO LEARN MORE ABOUT ROTARY: We attend club meetings, serve on committees, and make the most generous contributions we can. And that is all very important. But how much do we really know about this organization to which we belong?

R.I. President Charles C. Keller believes we all need to learn more. January has been designated as Rotary Awareness Month -- a time to learn about Rotary -- its traditions, philosophy, structure, and the Object of Rotary.

We can begin by reading the many publications offered about Rotary, especially the Rotary Basic Library (920-EN), the boxed seven-volume set that has been described as "the best source of Rotary in print." Let's not allow another day to pass without learning more about the world of Rotary--a world in which we are an integral part.

EVERYBODY . . . OR NOBODY: International Service begins with Rotarians adopting a world view grounded in the realization that human beings truly are dependent on each other's survival, that each man's community is part of a world neighborhood, that all wars are civil wars because all men are brothers. Never has the need shown itself with greater clarity than in the nuclear age. As the late U.S. philosopher-scientist R. Buckminster Fuller put it: "We are going to have to find ways of organizing ourselves cooperatively, sanely, scientifically . . . with the rest of humanity . . . It has to be everybody or nobody."

ARE WE READY FOR FOUNDATION MONTH? November is Rotary Foundation Month and we are asked to voluntarily consider a contribution to the Rotary International Foundation to support Rotary International scholarships and projects. The objective of the Rotary Foundation of Rotary International is the achievement of world understanding and peace through international charitable and educational programs. Rotary's Foundation was begun in 1917 by Arch Klumph, 6th International Pres. of Rotary, who convinced a Rotary convention of the need for an endowment for "doing good in the world" in charitable, educational or other avenues of service.

In addition to eliminating polio from the world, The Rotary Foundation now funds each year: 1) Approximately 1,000 scholarships for graduate, undergraduate, vocational and journalism scholars, and teachers of the handicapped; 2) Some 150 group Study Exchanges; 3) More than 70 international humanitarian projects through Special Grants and Health, Hunger, and Humanity Grants; and 4) Approximately 10 grants for University Teachers, to teach in nations other than their own, especially in developing countries.


